Changes in RID

to enter into force on 1 January 2019



Preamble

The new provisions of the Regulations concerning the International Carriage of Dangerous Goods by Rail (RID) **entered into force on the 1st of January 2019**. The UIP Guidelines should facilitate the understanding of the changes that will be introduced in the new version of the RID. The following document focuses on topics relevant to operators, keepers and ECM of tank wagons. RID applies to the international carriage of dangerous goods by rail between the 44 existing RID Contracting States in Europe, Asia and North Africa. In the Member States of the European Union, RID applies to national and international transport.

Point 6.8.3.2.9 - Design of Safety valves of gaswagons

- Shall be designed to prevent or be protected from the entry of water or other foreign matter which may impair their correct functioning. Any protection shall not impair their performance (e.g. freezing).
 - to be checked and if necessary changed during the next intermediate or periodic inspection after 1 January 2021

Point 4.3.5 TU 42 – Tanks with a shell constructed of aluminium alloy, including those with a protective lining

- shall only be used if the pH value of the substance is not less than 5.0 and not more than 8.0
 - may not be used for the carriage of such substances after 31 December 2026

Point 6.8.2.1.23 – Welding operations during maintenance and repair

- Clarification that the ability of the maintenance or repair shop to perform welding operations shall be verified and confirmed by the inspection body
 - The provision in the German RSRB on equal treatment of new builds and on authorisation by the safety authority (e.g. EBA) must be withdrawn

Point 6.8.2.4.2 - Inspections

 Clarification: Protective linings shall be visually examined for defects. In case defects appear the condition of the lining shall be evaluated by appropriate test(s).
